The projects are located as follows: C-25(41) - on Road 167 between Road 2 and Road 8, C-25(42) - on Road 167 between Road 8 and Road 12, and C-25(54) - on Old Highway 27 between Road 2 and Interstate 80, all in Deuel County, Nebraska.

The projects are referred to as "Deuel County 2018 Overlays: C-25(41), C-25(42) and C-25(54)" and shall include all labor, materials, transportation and equipment required for the construction of: Alternate 1) Cold Milling and a 2" Asphaltic Concrete Overlay, Type "SPR"; Alternate 2) Cold Milling and Double Armor Coat; or Alternate 3) Hot In-Place Recycling and Armor Coat for: C-25(41) - approximately 2.2 miles; C-25(42) - approximately 3.3 miles; and C-25(54) - approximately 3.5 miles.

Along with its Bid Proposal, each bidder shall submit an unconditional Bid Bond or Certified Check payable to the County Treasurer of Deuel County, Nebraska, in an amount equal to five (5) percent of the Bid Proposal. Also, each bidder is to provide a Start of Construction date and End of Construction date with its Bid Proposal. No work shall be performed and the roads shall remain open without restrictions from July 1, 2018 to July 31, 2018. The desired completion date for all projects is October 31, 2018. The Contractor will be allowed twenty (20) calendar days for Chappell South, C-25(41); thirty (30) calendar days for Chappell South, C-25(42); and thirty (30) calendar days for Chappell Southeast, C-25(54), after beginning work at each site. The Completion Date will be the earlier of the date indicated in the bid proposal or the actual start date plus the allotted calendar days for that site.

Within ten (10) days following the award of the Contract, the successful bidder shall furnish a surety bond or bonds in an amount equal to or greater than the full amount of the contract. The surety and form of the bonds are subject to acceptance by the Deuel County Board of Commissioners.
