Deuel County Commissioner Meeting

February 7, 2017

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jerry Radke and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Radke. Fischer, aye, Klingman, aye, Radke, aye. The minutes of the January 20, 2017 meeting were approved upon motion of Commissioner Radke, second of Commissioner Klingman. The Deuel County Comprehensive Plan was approved, after proof of publication and public hearing, upon motion of Commissioner Klingman, second of Commissioner Radke. Fischer, aye, Klingman, aye, Radke, aye.

The public hearing for the Deuel County One and Six road plan opened at 9:00 a.m. No one was present from the public to attend the meeting and provide input. There was no action for the Board of Equalization.

Terry Duffield requested gravel for the adopt-a-dog facility. The Commissioners instructed her to obtain a donation of gravel from the landowner and the County could assist with the transportation of the gravel to the facility.

Deuel County Clerk/Clerk of the District Court Polly Olson presented a report of fees collected for the month of January, 2017 in the amount of \$2,756.94. This report was reviewed and accepted for filing.

Sheriff Scott DeCoste presented a report of fees collected by his office in the amount of \$154.49. This report was reviewed and accepted for filing.

It was moved by Commissioner Fischer, second of Commissioner Klingman to advertise for a Supervisor for the Highway Dept. at \$18.00 per hour. All road personnel will answer directly to this individual. Radke, aye, Fischer, aye, Klingman, aye. Ads will be placed in the Chappell Register and the Sidney Sun, deadline to apply is February 17, 2017, 4 p.m.

Upon motion of Commissioner Fischer, second of Commissioner Klingman, Officer Administrator to the Highway Dept., Chautine Snell, will be paid \$14.60, effective March 1, 2017. Radke, aye, Fischer, aye, Klingman, aye.

No correspondence has been received from the State Veteran's Service regarding the appointment of a new Veteran's Service Officer.

County Treasurer Bernie Littlejohn indicated that she would like to install a ceiling fan in her office to properly distribute the heat/cooling in the Treasures' office. The Board would like to have the company that installed the units, Ameresco, come and address the situation prior to going ahead with the installation.

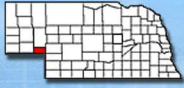
