Deuel County Commissioner Meeting

March 7, 2017

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jerry Radke, County Attorney Joel Jay and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Radke. Fischer, aye, Klingman, aye, Radke, aye. The minutes of the February 21, 2017 meeting were approved upon motion of Commissioner Radke, second of Commissioner Klingman. Deuel County Clerk/Clerk of the District Court Polly Olson presented a report of fees collected for the month of February, 2017 in the amount of \$3,119.47. This report was reviewed and accepted for filing.

It was moved by Commissioner Fischer, second of Commissioner Klingman to hire Kelly Kopetzky as the Highway Dept. Supervisor at \$18.00 per hour. All road personnel will answer directly to him. Radke, aye, Fischer, aye, Klingman, aye.

Applications for the road laborer position were reviewed. Four interviews will be conducted of the seven received. During the probationary period, the new hire will be paid \$15.00 per hour.

County Treasurer Bernie Littlejohn presented a report of the Public Sale of Delinquent Real Estate Taxes from March 6, 2017. The final total was \$13,575.01. This report was reviewed and accepted for filing.

Motion was made by Commissioner Fischer, second of Commissioner Klingman to contract as needed for a County Surveyor instead of filling the vacancy created by the resignation of David Mauthe. Radke, aye, Fischer, aye, Klingman, aye.

Alex Herrera was sworn in as Veteran's Service Officer for Deuel County. Upon motion of Commissioner Klingman, second of Commissioner Fischer, he will be paid \$700.00 per month beginning April, 2017. Radke, aye, Klingman, aye, Fischer, aye
