## Deuel County Commissioner Meeting

June 6, 2017

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jerry Radke, County Attorney Joel Jay and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Radke, second of Commissioner Klingman. Fischer, aye, Radke, aye, Klingman, aye. The minutes of the May 16, 2017 meeting were approved upon motion of Commissioner Klingman, second of Commissioner Radke. Fischer, aye, Klingman, aye, Radke, aye.

No business for the Board of Equalization.

Three building permits were submitted for approval. The first presented, as recommended by the zoning board, was for a conditional use permit splitting off 4.55 acres of land to change the use to residential. This permit was approved upon motion of Commissioner Fischer, second of Commissioner Klingman. Radke, aye, Fischer, aye, Klingman, aye. Two other permits were presented from AT&T, for updates to the radio towers, but failed to include the permit fee. The board will address these permits during the June 20 meeting.

Office Administrator Chauntine Snell and Highway Supervisor Kelly Kopetzky reported on activities within the Highway Dept. The glass in a grader door has again cracked. Discussion was held regarding turning the repair into the insurance company. If the cost is less than the deductible, it will not be turned in.

Joe Blanke and Bryan Hulbert with Murphy Tractor met with the board to introduce themselves and present a grader market report, not exclusive to John Deere. His plans are to present this report annually to help as the budgetary process begins.

Upon motion of Commissioner Radke, second of Commissioner Klingman, the board entered into an agreement for Highway Supt. Services in the amount of \$500.00 per month as retainer with Mark Mainelli of Mainelli, Wagner & Associates, Inc. Tony Armer will be the contacted Supt. Fischer, aye, Radke, aye, Klingman, aye.

Deuel County Clerk/Clerk of the District Court Polly Olson presented a report of fees collected for the month of January, 2017 in the amount of \$7,449.59. This report was reviewed and accepted for filing.

Resolution 2017-5, the 2017 Deuel County Local Emergency Operations Plan, (LEOP), was approved upon motion of Commissioner Klingman, second of Commissioner Radke. Fischer, aye, Klingman, aye, Radke, aye.

Deputy Deuel County Sheriff Spencer Rowley presented a report of fees collected by the Deuel County Sheriff Dept. in the amount of \$447.75 for the month of May, 2017.

County Insurance was an item of discussion. The board moved upon motion of Commissioner Klingman, second of Commissioner Radke the county will increase the Auto Physical deductible to \$500.00, the Inland Marine and Property deductibles to \$1,000.00 effective July 1, 2017. Fischer, aye, Klingman, aye Radke, aye. The County will also research the "cash in lieu of insurance" for future reference. This policy will not be offered as an option this year.

Warrants in the amount of \$123,658.83 were approved upon motion of Commissioner Klingman, second of Commissioner Radke. (Payroll \$29,214.52, Claims \$94,444.31). Klingman, aye, Fischer, aye, Radke, aye.
