Deuel County Commissioner Meeting

August 1, 2017

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jerry Radke, County Attorney Joel Jay and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Radke. Fischer, aye, Klingman, aye, Radke, aye. The minutes of the July 18 meeting were approved, with the clarification that Deuel County Treasurer Bernadette Littlejohn provided the board with the 6 month report (which was reviewed and accepted for filing), during the July 18 board meeting, upon motion of Commissioner Klingman, second of Commissioner Radke. There was no activity for the Board of Equalization.

Highway Supt. Tony Armer, Highway Supervisor Kelly Kopetzky and Office Administrator Chauntine Snell met with the board to discuss the operations of the highway dept.

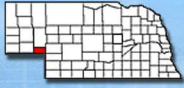
