Deuel County Commissioner Meeting

August 15, 2017

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jerry Radke and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Radke, second of Commissioner Klingman. Fischer, aye, Radke, aye, Klingman, aye. The minutes of the August 1 meeting were approved upon motion of Commissioner Klingman, second of Commissioner Radke. There was no activity for the Board of Equalization.

Highway Supt. Tony Armer, Highway Supervisor Kelly Kopetzky and Office Administrator Chauntine Snell met with the board to discuss the operations of the highway dept. Bridge Inspections will be conducted by Mainelli, Wagner & Associates as instructed by the Board of Commissioners.

Upon motion of Commissioner Klingman, second of Commissioner Fischer, a General Assistance Claim was approved in the amount of \$1,500.00 for burial expense. Radke, aye, Klingman, aye, Fischer, aye.

The budget workshop was held with C.P.A. Rachel Smith of Rauner and Associates. Preliminary budget requests were reviewed and the certified valuation presented. The budget hearing will be held on September 5, 2017 at 8:30 a.m.

Deuel County, Clerk of the District Court Polly Olson reported fees presented fees collected for the month of July in the amount of \$5,469.00. This report was reviewed and accepted for filing.
