#### February 20, 2018

Mike Samuelson of Reynolds, Korth & Samuelson of Ogallala met with the board to present a general overview of the Opioid Epidemic facing the nation. His office is in the process of getting the information out to counties to prepare them for the potential class action suit filed against the pharmaceutical companies that are promoting the marketing and distribution of highly addictive opioids. Mr. Samuelson will email the proposed contract, no cost to the county, (the law firm will receive compensation through contingency if there is a monetary recovery), for approval at a later date.

Sheriff DeCoste reported on the activities within his office.
