Deuel County Commissioner Meeting

March 6, 2018

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jerry Radke, County Attorney Joel Jay and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Radke, second of Commissioner Klingman. Deuel County Clerk, Clerk of the District Court Polly Olson, presented a report of fees collected by her office for the month of February, 2018, in the amount of \$3,860.96. This report was reviewed and accepted for filing

There was no action for the Board of Equalization.

One building permit was approved for Sprint was approved, as recommended by the Deuel County Zoning board, for the modifications of a tower as well as a 12 X 12 structure to be built, upon motion of Commissioner Klingman, second of Commissioner Radke. Fischer, aye, Klingman, aye, Radke, aye.

Noxious Weed Supt. Cris Burkes met with the board to discuss the weeds that are categorized as noxious to Deuel County. Discussion was held regarding common mullein and the methods of controlling it. Common mullein will not be categorized as a "county" noxious weed.

The quarterly safety committee was held with the following members present: Chair Chauntine Snell, Jim Hinnegan, Jerry Radke, Scott DeCoste and Kelly Kopetzky.

Office Administrator Chauntine Snell and Highway Supervisor Kelly Kopetzky, reported on activities within the Highway Dept. A discussion was held regarding the repairs to the heating of shop one. Upon motion of Commissioner Klingman, second of Commissioner Radke, Stegeman Services will be hired to install a heating unit in the amount of \$4,977.00. Fischer, aye, Klingman, aye, Radke, aye. Upon motion of Commissioner Klingman, second of Commissioner Radke, the County will purchase a mower from Big Springs Equipment in the amount of \$19,800.00, trade-in value of 1999 Rhino \$4,540.00, total price \$15,260.00. Treasurer Bernie Littlejohn presented a report of the Public Sale of Delinquent Real Estate Taxes: \$14,030.24 was collected for delinquent tax liens including interest and advertising fees. \$275.00 was collected for registration and certificate fees. Final total collected \$14,305.24. This report was reviewed and accepted for filing. Tax lien certificates will continue to be available as posted in the Deuel County Treasurer's office. Any tax lien sale will now be noted as a private sale.
