April 3, 2018

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steven Fischer, Commissioner Jerome Radke, County Attorney Joel Jay and County Clerk Polly Olson. Commissioner William Klingman was absent. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence.
