



# Deuel County Board Minutes



Deuel County Commissioner Meeting

August 7 2018

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jerome Radke, County Attorney Joel Jay and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Radke. Fischer, aye, Klingman, aye, Radke, aye. The minutes of the July 17, 2018 meeting were approved upon motion of Commissioner Klingman, second of Commissioner Radke. Fischer, aye, Klingman, aye, Radke, aye. .

Motion was made by Commissioner Radke, second of Commissioner Fischer to enter into the Board of Equalization at 8:32 a.m. Klingman, aye, Radke, aye, Fischer, aye.

Motion was made by Commissioner Radke, second of Commissioner Klingman, to resume the regular meeting at 8:34 a.m. Fischer, aye, Radke, aye, Klingman, aye.

Jeff Lampmann with the USDA met with the board and gave an over-view of the previous year pertaining to noxious weed control in and for Deuel County. It was reported that Deuel County has received the highest number of points that can be achieved, indicating that the contracted Noxious Weed Supt. Cris Burkes has provided excellent service to Deuel County.

A budget hearing was held with C.P.A. Rachel Smith of Rauner and Associates. No cuts are projected at this time. The board received a draft copy of the budget to review. The 2018 budget hearing will be held on Tuesday, September 4, 2018 at 9:00 a.m.

County Clerk/ Clerk of the District Court Polly Olson presented a report of fees collected for the month of July in the amount of \$3,673.95. This report was reviewed and accepted for filing.

Deputy Sheriff Cody Sellhorst reported on activities within the Sheriff's office. He presented a report of fees collected in the amount of \$418.52 for the month of July, 2018. This report was reviewed and accepted for filing. Discussion was held regarding the improvements on the county property used as an impound lot East of Chappell. Informal bids were requested and four received. Upon motion of commissioner Klingman, second of Commissioner Radke, the bid of Oilfield Insulators, L.L.C. of Chappell, in the amount of \$14,400 for the installation of a six foot chain link fence was accepted. This bid included that the removal of the old building and the old fence would be done and become the property of Oilfield Insulators. Fischer, aye, Klingman, aye, Radke, aye. Two informal bids were received for a building to be built on the property. Upon motion of Commissioner Klingman, second of Commissioner Fischer, a bid from Cleary Building of Scottsbluff in the amount of 425,565.00 for a building 30' wide by 40' long (with cement floor), using 26 gauge material. The building will be tan trimmed in white. Radke, aye, Klingman, aye, Fischer, aye. The building/fence removal and installation of the new fence will take place in august with the building to be completed in September. The Commissioners will request Sheriff DeCoste to obtain the building permit from the City of Chappell.

Warrants in the amount of \$132,109.47, were approved upon motion of Commissioner Fischer, second of Commissioner Klingman, (Payroll \$27,578. , Claims \$119,152.78 ), Radke, aye, Fischer, aye, Klingman, aye.
