Deuel County Commissioner Meeting

September 4, 2018

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, County Attorney Joel Jay and County Clerk Polly Olson. Commissioner Jerome Radke was excused from the meeting. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Fischer. Radke, absent, Klingman, aye, Fischer, aye. The minutes of the August 21, 2018 meeting were approved upon motion of Commissioner Fischer, second of Commissioner Klingman. Sheriff report of fees collected in the amount of \$66.10, collected in the month of August, was reviewed and accepted for filing.

The 2018 budget hearing was conducted. Due to the absence of Commissioner Radke, Resolution 2018-4 will have to be placed on the September 18 agenda, as it specifies that there must be 75% board approval. Upon motion of Commissioner Klingman, second of Commissioner Fischer, Resolution 2018-5, approving the Property Tax Request for 2018-2019 in the amount of \$2,063,263.87, for County General and \$25,026.36 for the County Fair. Upon motion of Commissioner Klingman, second of Commissioner Fischer, Resolution 2018-6, Deuel County Budget Document Resolution of Adoption and Appropriations, was approved.
