Deuel County Commissioner Meeting

October 2, 2018

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jerome Radke, County Attorney Joel Jay and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Radke, second of Commissioner Klingman. Fischer, aye, Klingman, aye, Radke, aye. The minutes of the September 18, 2018 meeting were approved upon motion of Commissioner Klingman, second of Commissioner Radke. Motion was made by Commissioner Fischer, second of Commissioner Klingman, to enter into the Board of Equalization at 8:31 a.m. Radke, aye, Fischer, aye, Klingman, aye.
