## Deuel County Commissioner Meeting

January 15, 2019

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm and Office Clerk Cyd Hanson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm. No action for the Board of Equalization.

Extension Educator Karen DeBoer met with the board to present the new 4-H Extension Educator Model which includes changes in the Extension Office Educator position. This will re-organize the way the counties are covered. Deuel County will share Extension Educator Services with Cheyenne County. The Officer Administrator will stay the same in Chappell.

Treasurer Bernie Littlejohn presented the 6 month treasurer's report. This report was reviewed and accepted for filing.

Christine Warner met with the Board to request \$3,000.00 as a need to keep the Deuel County Handibus to keep the services operational in partnership with Kimball County Transit Service and Chappell Senior Center. Her proposal includes Chappell being a satellite office of the Kimball county Transit Service. Questions were raised about use and maintenance of local handibus vehicles and the handling of titles of vehicles as well. An agreement will be provided by Kimball County to County Attorney Joel Jay for review prior to approval.

Discussion was held concerning consolidating the duties of the Ex Officio Clerk of the District Court and the County Clerk Magistrate into one position. County Attorney Joel Jay explained the procedure and answered questions. The Board instructed him to move forward with negotiations.

Sheriff Scott DeCoste reported on activities within his office. It was reported that the staff had attended training for E-Citations and the equipment has been installed in the vehicles.

Warrants in the amount of \$89,756.24, were approved upon motion of Commissioner Fischer, second of Commissioner Klingman, (Payroll \$27,393.18, Claims \$62,363.06), Timm, aye, Fischer, aye, Klingman, aye.
