

NOTICE OF PRIMARY ELECTION

Notice is hereby given that on Tuesday, May 12, 2020, at the usual polling places * in the precincts of Deuel County, Nebraska, a joint County, City, Village and School election will be held. The Polls will open at 7:00 a.m. and close at 7:00 p.m. Said election will be for nominating, or in some cases electing candidates to various offices.

In compliance with Section 32-428, Section 177-017.02 and Section 79-803.07 in those cases where the names of the candidates properly filed for nomination do not exceed two candidates for each vacancy to be filled, all so filed shall be nominated and no primary election will be held. Therefore, those candidates who have properly filed for the following offices : Chappell Airport Authority, Board of Education Creek Valley School District 25-1, Board of Education South Platte School District 95-1, Board of Directors, W.N.C.C. and Board of Directors of the South Platte NRD shall be considered to have been nominated and the names shall be printed on the November 3, 2020 General Election ballot. The number of candidates for delegates to County Convention in Chappell, Swan and Big Springs are the same or less than the number of candidates to be elected, therefore, the names shall not appear on the ballot and those so filed shall receive a Certificate of Nomination.
