

## NOTICE OF PRIMARY ELECTION

Notice is hereby given that on Tuesday, May 10, 2022, at the usual polling places \* in the precincts of Deuel County, Nebraska, a joint County, City, Village and School election will be held. The Polls will open at 7:00 a.m. and close at 7:00 p.m. Said election will be for nominating, or in some cases electing candidates to various offices.

In compliance with Section 32-428, Section 177-017.02 and Section 79-803.07 in those cases where the names of the candidates for Non-partisan offices properly filed for nomination do not exceed two candidates for each vacancy, also, those partisan office that have no opposition within the Partisan offices in the Primary Election shall be considered nominated and no primary election will be held. Therefore, those candidates who have properly filed for the following offices: County Assessor, County Attorney, County Clerk, County Commissioner Swan Precinct Chappell Airport Authority, Board of Education Creek Valley School District 25-1, Board of Education South Platte School District 95-1, Board of Directors, W.N.C.C. shall be considered to have been nominated and the names shall be printed on the November 8, 2022 General Election ballot. The number of candidates for delegates to County Convention in Chappell, Swan and Big Springs are the same or less than the number of candidates to be elected, therefore, the names shall not appear on the ballot and those so filed shall receive a Certificate of Nomination.
