



# Deuel County Board Minutes



Deuel County Commissioner Meeting

March 5, 2019

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Joel Jay and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm. Fischer, aye, Klingman, aye, Timm, aye. The minutes of the January 15, 2019 meeting were approved upon motion of Commissioner Timm, second of Commissioner Klingman. No action for the Board of Equalization.

County Clerk, Clerk of the District Court, Polly Olson presented a report of fees collected in her office for the month of February, 2019, in the amount of \$6,644.45, this report was reviewed and accepted for filing.

County Sheriff Scott DeCoste presented an amended report in the amount of \$411.32 for fees collected by his office (the original report was in the amount of \$258.82), for the month of January 2019. This report was reviewed and accepted for filing.

The quarterly safety committee meeting was held at 8:35 with the following members present: Chairperson Chauntine Leach, Joel Jay, Jean Timm, Scott DeCoste, and Kelly Kopetzky. Bo Fisher was excused. Discussion was held regarding accidents on county roads and preventative measures to avoid workman's comp claims. The ten best safety practices were discussed as Chad Engle with NIRMA had provided.

An amended lease agreement between Chappell Livestock and Deuel County was reviewed. The annual lease agreement will be in the amount of \$500.00. Discussion was held regarding the pens on the facility owned by Sandpoint. Mike Cavalli representing Sandpoint indicated that Sandpoint would accept \$10,000.00 for the pens, a reduction of \$18,000.00 from the original request to the county. The board request an itemized billing from Sandpoint in the form of a purchase agreement to be presented for payment. This allows the county to own all the equipment and the lessor will be able to have full use of the facility. Motion was made by Commissioner Klingman, second of Commissioner Timm to approve the lease with Chappell Livestock. Fischer, aye, Klingman, aye, Timm, aye.

The topic of working 4, ten-hour work days in the highway department was discussed. Upon motion of Commissioner Timm, second of Commissioner Klingman, the county road laborers will work 4 ten-hour work days beginning May 6, 2019 through September 27, 2019. Regular hours will commence Monday, September 30, 2019. Fischer, aye, Timm, aye, Klingman, aye.

A request was made by the Assembly of God Church, to enter into an agreement with the county to install a sprinkler system in the exhibit hall on the Deuel County fairgrounds. The organization is trying to find a secure place for the sale of the fireworks during those days allowable by law. They were informed by the State Fire Marshall that the building currently used on the fairgrounds was not in compliance with State regulations to store fireworks. Due to the costs associated with a project of the caliber, a motion was made by Commissioner Timm, second of Commissioner Klingman to not enter into an agreement for this purpose. Fischer, aye, Timm, aye, Klingman, aye.

Warrants in the amount of \$107,343.41, were approved upon motion of Commissioner Fischer, second of Commissioner Klingman, (Payroll \$28,021.82, Claims \$79,321.59), Timm, aye, Fischer, aye, Klingman, aye.
