Deuel County Commissioner Meeting

June 20, 2019

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Jonathon Stellar and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm. Fischer, aye, Klingman, aye, Timm, aye. The minutes of the June 4, 2019 meeting were approved upon motion of Commissioner Timm, second of Commissioner Klingman. Fischer, aye, Timm, aye, Klingman, aye.

No action for the Board of Equalization.

Bryan Venable representing P.A.D.D. met with the board to present information pertaining to the Panhandle Area Development District.

Upon motion of Commissioner Fischer, second of Commissioner Timm, approval was given for the fair board to apply for a Buckley grant to install an additional awning on the garden area of the fairgrounds. Klingman, aye, Fischer, aye, Timm, aye.

Upon motion of Commissioner Fischer, second of Commissioner Klingman, the May 22 decision of the propane contract with FVC was rescinded. Timm, aye, Fischer, aye, Klingman, aye. Upon motion of Commissioner Klingman, second of Commissioner Timm, the County will enter into a propane contract with FVC for 7,000 gallons, \$1.10 per gallon, prepaid amount \$7,700.00. Noxious Weed Supt. Cris Burks and Kelsey Kurth met with board to report on the activity in the weed dept. Discussion was held regarding forced control. Deuel County will begin forced control to control the noxious weeds in the county.

Upon motion of Commissioner Fischer, second of Commissioner Klingman, the board entered into executive session to review employee evaluations and consider employee increases at 9:42 a.m. with the following present: Commissioners Klingman, Timm, Klingman, Tony Armer, Highway Supervisor Kelly Kopetzky and Administrative Assistant Chauntine Snell.

Upon motion of Commissioner Fischer, second of Commissioner Klingman, the board resumed the regular meeting at 10:24 a.m. Timm, aye, Fischer, aye, Klingman, aye. No action was taken at this time regarding the pay increases.

The board toured the annex building to check on availability of resources and room for the county attorney.

It was decided that the county would no longer have a credit card for each office through U.S. Bank upon motion of Commissioner Fischer, second of Commissioner Klingman. Timm, aye, Fischer, aye, Klingman, aye. It will be up to each office to find a company if they need a credit card. The cut off day to use the current card is July 10.
