Deuel County Commissioner Meeting

July 2, 2019

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Jonthan Stellar and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm. Fischer, aye, Klingman, aye, Timm, aye. The minutes of the June 20, 2019 meeting were approved upon motion of Commissioner Timm, second of Commissioner Klingman. Fischer, aye, Timm, aye, Klingman, aye.

No action for the Board of Equalization.

County Clerk Polly Olson presented fees collected in her office for the month of June in the amount of \$1,354.97. This report was reviewed and accepted for filing.

Zoning Administrator Tony Armer met with the board to present a building permit for approval as recommended by the Deuel County Zoning Committee. Upon motion of Commissioner Fischer, second of Commissioner Klingman, the zoning permit for Avis Leach was approved as recommended. Timm, aye, Fischer, aye, Klingman, aye.

Discussion was held regarding one mile of road south of Big Springs and the frontage to the campground in Big Springs. Tony Armer presented a proposal from Mainelli and Wagner to provide the plan for the project in the amount of \$9,500.00. The bid proposal of CR 209/CR8 south of Big Springs was discussed. Motion was made by Commissioner Fischer, second of Commissioner Timm to accept the plan of Mainelli and Wagner in the amount of \$9,500.00 for the design and plan of the project which includes 2 miles of asphaltic on CR 209/CR8 south of Big Springs. Klingman, aye, Fischer, aye, Timm, aye. Bids for the hydraulic study were discussed. It was decided that Deuel County will conduct their own study. Motion of Fischer, second of Klingman, to deny both bids for the hydraulic study and withdraw from the FEMA claim for the flooding in March, 2019. Timm, aye, Fischer, aye, Klingman, aye. Upon motion of Commissioner Fischer, second of Commissioner Klingman, the job description of Highway Supervisor was approved. Timm, aye, Fischer, aye, Klingman, aye. Motion was made by Commissioner Fischer, second of Commissioner Klingman to provide the following salary increases: Each regular road employee will receive an increase based on 40 cents per hour, which is an \$832.00 annual increase, the highway supervisor will receive an increase of \$2,080.00, based on a one dollar per hour increase, administrative assistant will receive a salary increase of based on the 35 hour work-week, \$16.00 per hour. Longevity will continue. Timm, aye, Fischer, aye, Klingman, aye.

County Attorney Jonathon Stellar presented drafts of inter-local agreements for the School Resource Officer with Creek Valley Schools and South Platte Schools. Deputy Sheriff Bo Fisher was present representing the Sheriff Dept. The commissioners approved the contracts as presented and they will be forwarded to the respective schools for their approval.

Warrants in the amount of \$113,923.14, were approved upon motion of Commissioner Klingman, second of Commissioner Fischer, (Payroll \$32,938.81, Claim \$80,984.33), Timm, aye, Fischer, aye, Klingman, aye.
