Deuel County Commissioner Meeting

August 6, 2019

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Jonathon Stellar and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm. Fischer, aye, Klingman, aye, Timm, aye. The minutes of the July 16 and July 25, 2019 meetings were approved upon motion of Commissioner Timm, second of Commissioner Fischer. Klingman, aye, Timm, aye, Fischer, aye.

Upon motion of Commissioner Timm, second of Commissioner Klingman the board will enter into the Board of Equalization at 8:31 a.m. Fischer, aye, Timm, aye, Klingman, aye.

The board resumed the regular meeting at 8:33 a.m. upon motion of Commissioner Fischer, second of Commissioner Timm. Klingman, aye, Fischer, aye, Timm, aye.

County Clerk Polly Olson presented fees collected in her office for the month of July in the amount of \$857.48. This report was reviewed and accepted for filing.

The board discussed the potential negative fund balance in the fair fund and options available to bring it into compliance. Fair Board president Jeff Ortgies was present to provide input. Motion was made by Commissioner Timm, second Klingman to transfer \$22,000.00 from County General to County Fair. Fischer, aye, Timm, aye, Klingman, aye.

Christy Warner of Kimball County Transit met with the board to discuss the Memorandum of Understanding and report of activities with the transportation services. Motion was made by Commissioner Klingman, second of Commissioner Fischer, to provide \$3,000.00 during 2019-2020. County Attorney Stellar will be making the suggested changes to the M.O.U. and will be signed after reviewed by the Kimball County Attorney. Timm, aye, Klingman, aye, Fischer, aye.

Motion was made by Commissioner Timm, second of Commissioner Klingman to allow Liberty National to offer insurance services to the employees of Deuel County. These premiums will be at the employees cost as a payroll deduction if they chose to participate. Fischer, aye, Timm, aye, Klingman, aye.

Deputy Bo Fisher presented a report of fees collected by the Sheriff Dept. for the month of July, 2019 in the amount of \$100.82. This report was reviewed and accepted for filing. The Inter-locals for the School Resource Officer were received. Upon motion of Commissioner Timm, second of Commissioner Klingman, the Inter-local agreement for the School Resource Officer with South Platte Schools is approved. A claim in the amount of \$10,000.00 was received from Sandpoint Cattle Company for improvements at the Sale Barn. County Attorney Jonathon Stellar will review the claim and the lease prior to approval.
