Deuel County Commissioner Meeting

September 1, 2020

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Jonathon Stellar and County bubble Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved, with an emergency agenda item of request to apply for special designated permit, from Misty Jackson, upon motion of Commissioner Klingman, second of Commissioner Timm. After review, the Commissioners will approve said resolution and instruct the Deuel County Treasurer to issue Tax Sale Certificates.
