Deuel County Commissioner Meeting

September 15, 2020

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm was absent and excused, (County Attorney Jonathon Stellar arrived at 9:35 a.m.) and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Fischer. Timm, absent, Klingman, aye, Fischer, aye. The minutes of the September 1, 2020 meeting were approved upon motion of Commissioner Fischer, second of Commissioner Klingman. Timm, absent, Fischer, aye, Klingman, aye.

Motion was made by Commissioner Klingman, second of Commissioner Fischer, to enter into the Board of Equalization to hear tax list corrections at 8:32 a.m. Timm, absent, Fischer, aye, Klingman, aye.

Motion was made to reconvene by Commissioner Klingman, second of Commissioner Fischer, at 8:35 a.m. Timm, absent, Klingman, aye, Fischer, aye.

Commissioner William Klingman read a Proclamation; Resolution 2020-5. Upon motion of Commissioner Klingman, second of Commissioner Fischer. Timm, absent, Klingman, aye, Fischer, aye.

The Deuel County Budget Hearing was held at 9:00 a.m. upon motion of Commissioner Fischer, second of Commissioner Klingman. Timm, absent, Fischer, aye, Klingman, aye. No changes were made to the budget document from the initial workshop in August. Upon motion of Commissioner Klingman, second of Commissioner Fischer, Resolution 2020-6, authorizing a transfer in the amount of \$85,553.00 from Road and Bridge to the Bond Fund was approved. Timm, absent, Klingman, aye, Fischer, aye. Resolution 2020-7, authorizing a transfer in the amount of \$491,061.00 from County General to Road and Bridge was approved upon motion of Commissioner Klingman, second of Commissioner Fischer. Timm, absent, Klingman, aye, Fischer, aye. Resolution 2020-8, authorizing a transfer in the amount of \$23,757.00 from County General to 911, was approved upon motion of Commissioner Fischer, second of Commissioner Klingman. Timm, absent, Fischer, aye, Klingman, aye. Resolution 2020-9, authorizing a transfer in the amount of 10,000.00 from County General to the Sheriff Sinking fund was approved upon motion of Commissioner Klingman, second of Commissioner Fischer. Timm, absent, Klingman, aye, Fischer, aye. Resolution 2020-10, approving an additional 1% request was approved upon motion of Commissioner Fischer, second of Commissioner Klingman. Timm, absent, Fischer, aye, Klingman, aye. (This Resolution had to be approved by 75% of the board members present.) Resolution 2020-11, the tax request \$1,954,154.10 at the tax rate of .485600, (rates different than last year) was approved upon motion of Commissioner Klingman, second of Commissioner Fischer. Timm, absent, Klingman, aye, Fischer, aye. Resolution 2020-12, authorized the following petty cash funds: County Attorney \$500.00, County Court \$25.00. Upon motion of Commissioner Klingman, second of Commissioner Fischer, Resolution 2020-12 was approved. Timm, absent, Klingman, aye, Fischer, aye. Motion was made by Commissioner Fischer, second of Commissioner Klingman, to approve Resolution 2020-13, the 2020-2021 budget document. Timm, absent, Fischer, aye, Klingman, aye. Upon motion of Commissioner Fischer, second of Commissioner Klingman, the budget hearing concluded. Timm, absent, Fischer, aye, Klingman, aye.

Bids were opened for the Day Road project located North of Big Springs. Three bids were received this morning prior to the 9:30 a.m. deadline. Highway Supt. Tony Armer was present to open the bids and offer explanation. Bids include A: Deuel County 9 miles and B: Garden County 1 mile.

It appeared that all bids followed the specifications, the bids were within 10% of each other. It was the recommendation of Armer to approve the bid of Paulsen. Motion was made by Commissioner Klingman, second of Fischer, to award the bid to Paulsen, Inc. of Cozad. Timm, absent and excused, Klingman, aye, Fischer, aye. Funds in the form of a highway allocation bond have been received by County Treasurer Bernadette Littlejohn. The board indicted that they would like to have the project completed this year if at all possible, weather permitting.

The quarterly safety committee meeting was held with the following present: Chairperson Marica Schievelbein, Chauntine Snell, Kelly Kopetzky and Jonathon Stellar. No accidents were reported on county roads upcoming safety training was discussed. The next quarterly meeting is scheduled for December 8, 2020.

BE IT RESOLVED BY THE CHAIRPERSON AND COUNTY BOARD OF COMMISSIONERS OF THE COUNTY OF DEUEL, NEBRASKA, as follows:

WHEREAS, the Fourteenth and Fifteenth Amendments to the United States Constitution, adopted in 1868 and 1870, respectively, as part of the Bill of Rights, protects the inalienable and individual right of the people to vote; and

WHEREAS, Article I, Section 22 of the Constitution of Nebraska provides that “All elections shall be free; and there shall be no hindrance or impediment to the right of a qualified voter to exercise the elective franchise.”; and

WHEREAS, Article I, Section I-7 of the Constitution of Nebraska provides that “The right of the people to be secure in their persons, houses, papers, and effects against unreasonable searches and seizures shall not be violated; and no warrant shall issue but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the person or thing to be seized.”; and

WHEREAS, it is the desire of the County Board to declare its support of the Fourteenth and Fifteenth Amendments to the United States Constitution and the Nebraska Constitution protecting citizens’ inalienable and individual right to vote; and

WHEREAS, the members of this Board took an oath to support and defend the United States Constitution, the Constitution of the State of Nebraska and the laws of the State of Nebraska, insofar as they are constitutional.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Deuel, Nebraska by the authority granted the Board by the laws of the State of Nebraska and people of Deuel County, Nebraska, we hereby declare that we shall stand and defend the rights and liberties of all county citizens, which are guaranteed by the United States and Nebraska Constitutions and that we encourage the people of Deuel County, Nebraska to exercise their right to vote in the upcoming election.
