Deuel County Commissioner Meeting

October 20, 2020

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm was absent and excused, and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Fischer. Timm, absent, Klingman, aye, Fischer, aye. The minutes of the October 6, 2020 meeting were approved upon motion of Commissioner Fischer, second of Commissioner Klingman. There was no action taken for Board of Equalization. Discussion was held regarding the appeal decision that has been released, in the favor of the county, filed by Frenchman Valley. This item will be placed on the agenda at a later date.

Noxious Weed Supt. Cris Burks met with the board to review and submit the annual Noxious Weed contract for Services. Services will remain the same, the annual contract fees will be an additional \$1,200.00. (\$2,100 per month instead of the current \$2,000.00). Upon motion of Commissioner Klingman, second of Commissioner Fischer, the contract if approved. Timm, absent, Klingman, aye, Fischer, aye.

The Management Representation Letter, as submitted by C.P.A. Donald Wilson, was approved upon motion of Commissioner Fischer, second of Commissioner Klingman. Discussion was held in consideration of hiring a full-time highway supt. Research will be conducted as the appointment could be made during the re-organizational meeting held in January.
