



# Deuel County Board Minutes



Deuel County Commissioner Meeting

December 1, 2020

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, (appeared via telephone due to COVID-19) and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Fischer. Timm, aye, Fischer, aye, Klingman, aye. The minutes of the November 17, 2020 meeting were approved upon motion of Commissioner Klingman, second of Commissioner Timm. Fischer, aye, Klingman, aye, Timm, aye.

Upon motion of Commissioner Fischer, second of Commissioner Klingman, the board entered into the Board of Equalization to hear Tax List Corrections and Motor Vehicle Exemptions at 8:31 a.m. Timm, aye, Fischer, aye, Klingman, aye.

Motion was made by Commissioner Klingman, second of Commissioner Timm, to reconvene the regular meeting at 8:37 a.m. Fischer, aye, Klingman, aye, Timm, aye.

County Clerk Polly Olson presented a report of fees collected in the office for the month of November, 2020, in the amount of \$1,168.99. This report was reviewed and accepted for filing.

The Commissioners discussed the unpaid rentals of the fairgrounds. Deuel County Treasurer presented receipts for rentals that the board was not aware of, there were no agreements or scheduled rentals. The board will direct County Attorney Jonathon Stellar to pursue the collection of the unpaid rentals, it would appear to show favoritism when waiving the fee for some and not for all. No rentals will be authorized until further notice. The board also discussed appointing a Commissioner liaison to attend fair board meetings.

Due to the operations during the spring pandemic outbreak, the contract with Mark Mainelli was not renewed in May as in the prior year. Upon motion of Commissioner Klingman, second of Commissioner Fischer, the Board affirms that the 2020 Deuel County Highway Supt. services were contracted with Mark Mainelli, of Mainelli and Wagner. The Deuel County Commissioner met on the above date as the Board of Equalization at 8:31 a.m. upon motion of Commissioner Fischer, second of Commissioner Klingman, aye, Timm, aye, Fischer, aye, Klingman, aye. The purpose of the meeting was to hear Tax List Corrections and Motor Vehicle Exemptions. The following officials were present: County Commissioners Klingman, Fischer, Timm (via telephone due to COVID-19), County Clerk Olson, County Assessor Schievelbein, Treasurer Littlejohn.

Tax List Correction #846, Parcel Ids #2805, #3810, #3910 and #43, Land that was previously owned by Delbert Harris and sold to the State of Nebraska. This correction would remove it from the tax rolls as the State of Nebraska is exempt from taxes. Tax List Correction #847, removing the taxes on panels that are on leased land (fair grounds) for Chappell Livestock. Upon motion of Commissioner Klingman, second of Commissioner Fischer, Tax List Corrections #846 and #847 are approved. Timm, aye, Klingman, aye, Fischer, aye.
