Deuel County Commissioner Meeting

March 16, 2021

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm was absent and excused, County Attorney Jonathon Stellar and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Fischer. Edmond Davidson requested permission to use the County Keno License. Treasurer Bernadette J. Littlejohn presented a report of the Public Tax Sale from March 1, 2021. Nine of the 33 tax liens that were advertised were sold, eight were paid prior to the sale. \$14,78.24 was collected for delinquent tax liens. \$255.00 was collected for registration and certificate fees. The final total collected was \$14,963.24. This report was reviewed and accepted for filing upon motion of commissioner Klingman, second of Commissioner Fischer. Operations of the highway department were discussed. It was reported that the M series grader is in need of repairs, the transmission has gone out.

Sheriff Scott DeCoste reported on activities within his office. Fees collected for the month of February are in the amount of \$151.77. This report was reviewed and accepted for filing. A new officer has been hired. This individual already has Nebraska Certification.

Appreciation was expressed to the Sheriff's Department and Administrative Assistant for the services provided during the burdensome events as a result of the inclement weather creating the road closures.
