Deuel County Commissioner Meeting

April 6, 2021

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Jonathon Stellar and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm. Fischer, aye, Klingman, aye, Timm, aye. The minutes of the March 16, 2021 meeting were approved upon motion of Commissioner Timm, second of Commissioner Klingman. Fischer, aye, Timm, aye, Klingman, aye.

County Clerk reported fees collected by her office for the month of March, 2021 in the amount of \$3,231.86 This report was reviewed and accepted for filing.

Motion was made by Commissioner Klingman, second of Commissioner Timm to enter into Board of Equalization at 8:36 a.m. Fischer, aye, Klingman, aye, Timm, aye.

Motion was made by Commissioner Fischer, second of Commissioner Klingman to resume regular session at 8:38 a.m. Timm, aye, Fischer, aye, Klingman, aye.

County Attorney Stellar gave an update of the NIRMA progress with litigation of Frenchman Valley Coop. He reported that a signed copy has not been received. The Commissioners expressed a desire to have the "confidentiality" clause removed from the agreement prior to any agreement, as they feel there should be transparency .

Discussion was held regarding courthouse security and privacy of email accounts. The county currently has a domain set up by the Assessor's office that allows for secure email. Michelle Bartlett of the Assessor's office will issue the addresses to those who would like one within the county offices.

Brent Fletcher request permission to obtain a special designated permit for May 8, 2021 on the fairgrounds 4-H building for a graduation celebration. Upon motion of Commissioner Fischer, second of Commissioner Timm, Brent Fletcher is allowed to obtain the special designated permit (SDP) from the Nebraska Liquor Control Commission. Edmond Davidson of Rockin5T, L.L.C., dba the Rusty Bucket is authorized as a sales outlet under the County/City lottery Act, for Lotto Nebraska Keno at the current location of the Rusty Bucket upon motion of Commissioner Timm, second of Commissioner Klingman. Operations of the highway department were discussed. It was reported that the Day Road Project is right on schedule and the project appears to be running smoothly.
