Deuel County Commissioner Meeting

May 18, 2021

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Jonathon Stellar and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm. Fischer, aye, Klingman, aye, Timm, aye. The minutes of the May 4, 2021 meeting were approved upon motion of Commissioner Timm, second of Commissioner Klingman. No action for the Board of Equalization.

Megan Ware, representing the NACO group Vision Service Plan, presented information pertaining to the National Insurance Services. The NACO group plan is at a reduction in cost to the employee and additional coverage as a benefit. Upon motion of Commissioner Klingman, second of Commissioner Timm, the county employees will be offered the Vision Service Plan benefits as a voluntary payroll deduction. The quarterly safety committee meeting was held at 8:59 a.m. with all members present. CPR and Stop the Bleed classes will be held June 14 for the county employees. Two sessions, morning and afternoon, will be held and lunch served. The safety committee meeting adjourned at 9:07 a.m. The next safety committee meeting will be held August 17.

Highway Supt. Anthony Armer met with the board to discuss the operations of the highway dept. Progress has been made on the Day Road project. There were some complications due to the poor "subgrade". An approximate additional \$34,653.00 will be added to the projected costs due to the preparation that needed to be completed. The 2015 Pickup has been totaled on May 7, 2021. No injuries were incurred. NIRMA adjusters have been notified and are working on the terms of the claim.

The Articles of Incorporation for the Aging Office of Western Nebraska were reviewed and accepted as presented upon motion of Commissioner Klingman, second of Commissioner Timm. Fischer, aye, Klingman, aye, Timm, aye.
