Deuel County Commissioner Meeting

September 7, 2021

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Jonathon Stellar and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm. Fischer, aye, Klingman, aye, Timm, aye. The minutes of the August 17, 2021 meeting were approved upon motion of Commissioner Timm, second of Commissioner Klingman. County Clerk reported fees collected by her office for the month of August, 2021 in the amount of \$1,024.97. This report was reviewed and accepted for filing.

No action for the Board of Equalization.

Operations of the highway department were discussed. There are currently two positions open within the Highway Dept. Interviews have been conducted for the five individuals that applied for the positions. County Road Supt. Armer recommended Daniel Hernandez be hired for the Big Springs shop and Mitchell Theimann be hired for the Swan shop. Motion was made by Commissioner Timm, second of Commissioner Klingman, to accept the recommendation and instruct Armer to offer the job to these two individuals starting wage to be \$16.00 per hour. Chris Vail, presented Keith County Scrap Tire collection event. The total cost of the event may be \$40,000.00, it is a refundable grant. Keith County has agreed to provide \$30,000.00 for the event. The original request to Deuel County was for \$5,000.00. She reported that she no longer needs funds for the project, as the state grant was awarded, but wanted to let the Commissioners know how Deuel County can participate in the entire program and that the schools will be receiving educational services in both Big Springs and Chappell.

Don Lease representing Nebraska Strong reported on activities within the Panhandle that have been occurring. He presented a resolution pertaining to declaring November as National Hunger and Homelessness Awareness month. This item will be placed on the next agenda for discussion and approval. He reported that the month of September has been designated as National Recovery Month. Purple pinwheels will be placed at various locations in observance of this designation.

The 2021 Budget hearing was conducted at 9:17 a.m. The final budget document received last week was reviewed by each Commissioner. There was no public comment, discussion was held pertaining to
