Todd Lewis of Bytes Managed IT services provided a technology overview. He discussed the Executive Summary conducted by his company for potential services can be offered to Deuel County. The cost of the total packet he would suggest is \$70,000.00. There would be an additional \$100.00 per month for each user. County Attorney Stellar said that this would not have to be bid out, but could be if the board would like. Grants could be available through HAVA, (Secretary of State) and CARES Act funding could be used for this type of project.
