Deuel County Commissioner Meeting

November 16, 2021

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. There was no public comment. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm. Fischer, aye, Klingman, aye, Timm, aye. The minutes of the November 2, 2021 meeting were approved upon motion of Commissioner Timm, second of Commissioner Klingman. Fischer, aye, Timm, aye, Klingman, aye.

Upon motion of Commissioner Fischer, second of Commissioner Klingman, the board entered into the Board of Equalization to hear Protests of Real Property at 8:35 a.m. Timm, aye, Klingman, aye, Fischer, aye.

Motion was made by Commissioner Klingman, second of Commissioner Timm, to reconvene the regular meeting at 8:37 a.m. Fischer, aye, Klingman, aye, Timm, aye.

Assessor Marica Schievelbein announced her resignation, due to relocation, effective December 1, 2021. Upon motion of Commissioner Klingman, second of Commissioner Timm, the resignation was accepted, with regret. Fischer, aye, Klingman, aye, Timm, aye.

The quarterly safety committee meeting was held with the following members present: Chairperson Marica Schievelbein, Kelly Kopetzky, Alicia Adams, Jean Timm and Anthony Armer. No workman's comp claims were filed this quarter and no accidents on county roads were reported.

Operations of the highway department were discussed. Highway Supt. Armer presented a report of activities within his office.

No building permits were submitted for approval as the zoning board did not have a quorum to approve the permits prior to the meeting.

Discussion was held regarding adding another member to the Deuel County Fair board. No action was taken on this matter. It will be re-visited during the January 2022 re-organizational meeting.

County Attorney Stellar arrived.

Sheriff Scott DeCoste reported on activities within his office.

Anthony Armer presented the BYTES IT Service contract for approval. The cabling expenses will be \$7,737.40 to be paid to DP Electronics. Three people will act as contacts, Tony Armer, Leslie Snell and Michelle Bartlett. Emergency contacts will be Michelle Bartlett and Leslie Snell. Upon motion of Commissioner Klingman, second of Commissioner Timm, the Service Contract was approved. Fischer, aye, Klingman, aye, Timm, aye.

Motion was made by Commissioner Fischer, second of Commissioner Klingman, to advertise for a lodging tax committee member. Brian Riggs had resigned during the September tourism meeting. As the board has yet to receive a written resignation no action had been taken. County Attorney Stellar advised that the minutes could be used and the board could continue filling the board member position. The appointment will be made during the December 7 Commissioner Meeting.
