



# Deuel County Board Minutes



## Deuel County Commissioner Meeting

January 18, 2022

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman Commissioner Timm, County Attorney Stellar, County Sheriff DeCoste, County Assessor Bartlett and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. There was no public comment. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm. Fischer, aye, Klingman, aye, Timm, aye. The minutes of the January 4, 2022 meeting were approved upon motion of Commissioner Timm, second of Commissioner Klingman. There was no action for Board of Equalization.

Assessor Michele Bartlett provided information pertaining to the Property Tax Administration Division recommendation to amend the comprehensive plan for Deuel County regarding easements on CRP and CREP ground. It appears that it would create an additional step for the landowner, duplicating the information that is already in place. No action was taken.

Anthony Armer presented information pertaining to the Phone system. First call, \$41.62 per month, is based out of Casper, Wyoming and Ring Central, \$38.62 per month, (unknown base location). Both had comparable systems, but with some with additional hidden fees. Upon motion of Commissioner Timm, second of Commissioner Fischer, the county will proceed with First Call, as recommended by "Bytes". It was reported that the phones, (numbers will remain the same) will be an additional cost but the savings in having this type of phone system will potentially cut the monthly costs in half. The type of phone will be chosen after each office is contacted. Installation should take place by the end of February. Klingman, aye, Timm, aye, Fischer, aye.
