Deuel County Commissioner Meeting

May 3, 2022

The Deuel County Commissioners met on the above date with the following officials present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, County Assessor Michele Bartlett, County Treasurer Alicia Adams, County Sheriff Scott DeCoste and County Clerk Polly Olson. The meeting, notice of which was published in the Chappell Register as according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm. County Clerk reported fees collected by her office for the month of April, 2022, in the amount of \$3,250.86 This report was reviewed and accepted for filing.

Assessor Michele Bartlett presented a contract for the additional GIS layers for Deuel County Assessments. This would be at a reduced rate due to the sales of Deuel County information collected by GIS program. Upon motion of Commissioner Timm, second of Commissioner Klingman, the creation of an improvement on leased land layer and cadastral map layers was approved. Fischer, aye, Timm, aye, Klingman, aye.

Discussion was held regarding the Blue Cross Blue Shield Sub group applications for 2022-2023. The county currently offers \$2,500.00 deductible with co-pay. The county will make a decision prior to the May 19 deadline for submission.

County Attorney Jonathon Stellar was contacted via cell phone to give an update regarding the Management Representation Letter and Audit findings.
