## Deuel County Commissioner Meeting April 2, 2024

The Deuel County Commissioners met on the above date with the following present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Jon Stellar, County Treasurer Alicia Adams, County Assessor Michele Bartlett, Sheriff's office administrator Leslie Snell, Sheriff Scott DeCoste, Deputy Jim McCormick, Roads Superintendent Kelly Kopetsky, Highway Superintendent Tony Krajewski, Kristian Fusilier, Cris Burks, Brent Fletcher, Mike Hansen, Jeff Ortgies and Clerk Tammy Sherman. The meeting, notice of which was published in the Chappell Register according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm; Fischer, aye, Klingman, aye, Timm, aye. The minutes of the March 19, 2024, meeting was approved upon motion of Commissioner Timm, second Commissioner Klingman. Fischer, aye, Timm, aye, Klingman, aye.

Public comment. None.

The Deuel County Court fee report for March was presented for review and filing. The fee totals \$7,350.69. The Deuel County Clerk's office monthly report for March was presented for review and filing. The fee totals \$2,930.36. The Deuel County Tourism report for February was presented for review and filing.

A motion by Commissioner Klingman seconded by Commissioner Timm to enter the Board of Equalization at 8:35 a.m. Fischer aye, Klingman aye, Timm aye.

After a brief discussion, a committee will be organized to supervise the trap shooting range at the fairgrounds. Sherrif DeCoste and County Attorney Stellar will be a part of the committee.

Weed Superintendent Cris Burks announced to the Commissioners that she has sold her business to Brent Fletcher. He will be assuming the duties of Weed Superintendent with Burks aiding for one year. The Commissioners expressed their sincere appreciation of Burks' service as Weed Superintendent for the past 12 years.

Planning Administrator Michele Bartlett presented proposed building permit fee changes as directed by the Planning & Zoning Board. Changes will be made to the proposed fee schedule and presented as resolution for approval.

The public hearing for the One (1) and Six (6) Year Road Plan for Deuel County, NE was opened at 9:00 a.m. Highway Superintendent Tony Krajewski presented the plan. Fischer asked for public comment. None. Resolution #24-005 was presented as follows: At the regular meeting of the Deuel County Board of Commissioners in Chappell, NE, held at the Deuel County Courthouse on April 2, 2024, a hearing was held on the 2024 One (1) and Six (6) Road Plan at 9:00 a.m., as advertised. Following discussion by the Board of Commissioners and citizens present, a motion was made to adopt the One (1) and Six (6) Year Road Plan for the Fiscal Year 2024 as proposed. Motion to approve Resolution 24-005 by Commissioner Klingman, seconded by Commissioner Timm. Fischer, aye, Timm, aye, Klingman, aye. The public hearing was closed at 9:10 a.m.

Highway Superintendent Krajewski updated the Board on the operations in the roads department. Krajewski presented an informal bid for labor to repair the dam on Wheatland Road for \$35,265.00. The County will pay for the cost of the materials to fix the area. That cost is estimated at \$45,000. A motion by Commissioner Klingman, seconded by Commissioner Fischer to accept the informal bid for labor work from Shelco Asphalt and Paving as presented by Krajewski. Fischer, aye, Klingman, aye, Timm, aye. The work will start after the wheat harvest. The roads department is continuing the patch work as needed on Road 167.

Jeff Ortgies from Frenchman Valley Coop discussed the 2024 fuel contract. It was agreed that the county should contract fuel with Frenchman Valley Coop. They asked Krajewski and Kopetsky to work with Ortgies to figure out the number of gallons to contract.

A motion by Commissioner Klingman, seconded by Commissioner Fischer to buy two 20 ft shipping containers for storage to be used by the Sheriff's Department. Fischer, aye, Timm, aye, Klingman, aye.

Sheriff DeCoste reported for the Sheriff's office.

A motion by Commissioner Klingman, seconded by Commissioner Fischer to appoint Scott DeCoste as Deuel County 911 Coordinator on a trial basis effective April 1<sup>st</sup>, 2024, for a wage of \$400 per month. Fischer, aye, Klingman, aye, Timm, aye.

Warrants for \$162,881.58 were approved upon motion of Commissioner Timm, second of Commissioner Klingman (Payroll \$38,518.94 Claims \$124,362.64); Fischer, aye, Timm, aye, Klingman, aye.

The Special Public Hearing was held to review the Permissive Exemption for the Phelps Hotel, in Big Springs as advertised. The State of Nebraska is questioning the exemption status. County Assessor Bartlett presented letters from the caretakers of the hotel, a local property owner and her reasons for keeping the exemption status. Fischer asked for public comments. None. A motion by Commissioner Timm, seconded by Commissioner Fischer to approve the Permissive Exemption status for the Phelps Hotel, in Big Springs as recommended by County Assessor Bartlett.
